US\$90 Million Senior Secured Bond Issue – Pathway to Gold Production

Transaction Highlights:

- **Oversubscribed US\$90 million (~A\$126 million¹) Binding Senior Secured Callable Bond Issue**
- **Net proceeds to fund TGME Gold Mine Project in South Africa - construction is progressing on budget, plant commissioning is targeted for late 2026, with first gold pour expected in the first quarter of 2027**
- **No mandatory hedging requirement; no options, warrants or royalties required as part of the bond financing**
- **No principal repayment for 30 months; then US\$7.5m quarterly amortisation to maturity and final repayment**
- **Flexible covenant package - Bond Issue provides access to a deep global institutional capital pool for further growth and investment opportunities**
- **Bonds are expected to be issued in mid-June 2026 with release of the bond funding subject to commercial conditions precedent**
- **The Bond Issue now completes the debt raising process for the Company**
- **Pareto Securities acted as sole Bond Manager, Argonaut acted as financial advisor**

Theta Gold Mines Limited (“TGM” or the “Company”) (ASX: TGM) has completed a binding fully oversubscribed US\$90 million (approximately A\$126 million) Senior Secured Callable Bond issue to fund construction of the TGME Gold Mine Project in South Africa. The Bond Issue was arranged by Pareto Securities and attracted strong demand from international institutional investors, following completion of the revised Definitive Feasibility Study in February 2026².

The Bond Issue now completes the debt funding process for the Company and enables TGM to progress the remaining construction and development of the TGME Gold Mine and advance the project towards gold production in 2027.

Comments by Theta Gold’s Chairman, Bill Guy:

Bill Guy, Chairman: *“The TGME Gold Mine project is a cornerstone development initiative for the region, poised to drive economic growth and create meaningful opportunities for the local community. With an expected sustainable mine life exceeding 13 years, the project is well positioned to deliver long-term value, generating enduring benefits for both shareholders and the broader community for years to come.”*

“This bond financing structure provides substantial operational flexibility and opens access to a deep global institutional capital base, significantly strengthening the Company’s platform for delivery and future growth.

“Construction activities continue to progress on budget, plant commissioning is targeted for late 2026, and Theta Gold remains on track to achieve first gold in the first quarter of 2027.”

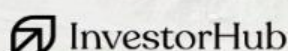

TGM's core project is located next to the historical gold mining town of Pilgrim's Rest, in Mpumalanga Province, some 370km northeast of Johannesburg by road or 95km north of Nelspruit (Capital City of Mpumalanga Province). Following small scale production from 2011 – 2015, the Company is currently focusing on the construction and financing of a new gold processing plant.

TGM holds 100% of Theta Gold SA (Pty) Ltd, which in turn owns 74% of TGME and Sabie Mines, meeting Black Economic Empowerment (BEE) ownership standards as per South African Mining Charter requirements.

The Company revised its Definitive Feasibility Study (DFS) on 3 February 2026 for its TGME Gold Mine Project which show cases a Life of Mine of 13.1 years with a NPV of A\$689m and free cash flow of \$A1.4B at an average spot gold price of US\$2,884.
